### Interest rate

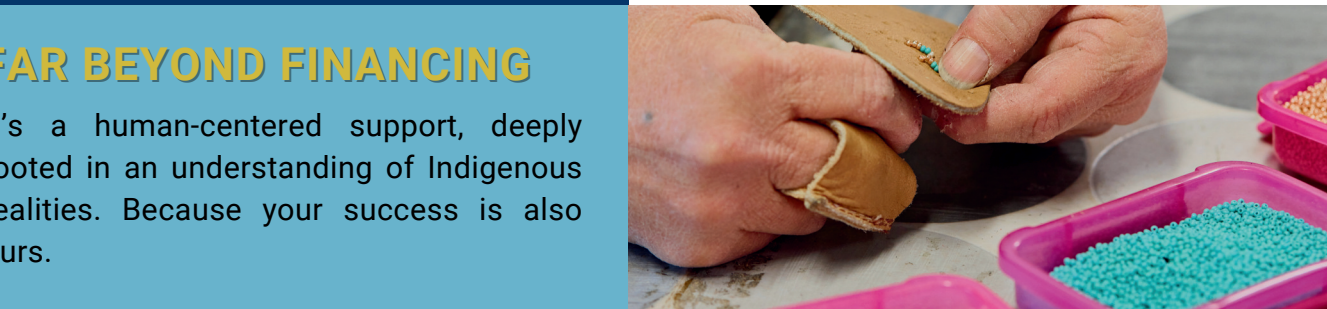

### Aboriginal Business Development Program (ABDP)

For a private project, up to

**\$99,999**

For a community project, up to

**\$250,000**

### Eligible activities and maximum contribution rate

- Preliminary studies : **75%**
- Capital costs : **40%**
- Marketing activities : **60%**
- Management support : **75%**

#### IMPORTANT :

*No costs incurred prior to final approval of your application will be considered eligible.*



### Eligibility criteria\*

- Project phase : **Start-up, business acquisition and expansion;**
- Down payment (10% to 25% of the cost of the project);
- Viable/profitable business project;
- Experience and training in the field of activities;
- Mandatory full-time involvement in the business.
